The “Playmate of the Decade” shooting in ... Playboy Mansion’s garden?

2023, a day in May: on Jeny’s YouTube channel a short video appeared showing her in front of the Los Angeles skyline by night. Los Angeles? Wow! Totally unexpected! What does she do there?
